

## General Fact Sheet | Terp Young Scholars Program

The Terp Young Scholars Program at the University of Maryland and ASRC Federal (“Sponsor”) invite **ASRC Shareholder High School Students**, to participate in an immersive three-week pre-college experience. Students enroll in the course of their choosing, go on field trips around DC, and see what it’s like to live and succeed in college. Students will attend class and stay in the dorms at the University’s College Park campus, only a few miles from ASRC Federal’s headquarters in Beltsville, Maryland. The Terp Young Scholars Program is for highly motivated, college-bound high school students who want to learn first-hand what it takes to succeed in college.

### Program Details

- **Program Dates: July 8 – July 27, 2018** (not including potential travel days).
  - Three week-long program; ASRC Federal Scholarship recipients arrive a day early and leave a day later than Program Dates.
- Students live and eat on University of Maryland, College Park campus.
- Students attend class in the morning, five days a week and participate in field trips/social activities on evenings and weekends.
- Upon successful completion of their course, students have the opportunity to receive up to three University of Maryland credits that may be transferrable to universities and colleges across the country.

Courses are offered on a first-come, first-serve basis, so applying early is recommended! Below are a few of the courses available for the 2018 summer:

- **Creative Writing**
- **Environmental Biology**
- **Think like an Economist**
- **Intro to Computer Programming**
- **Discovering Architecture**
- **Engineering Design**

Scholarships are awarded to the first eight students accepted to the program by the University of Maryland. To be eligible for the scholarship, a student **MUST** return the ASRC Federal application form using the Application Procedure below **BEFORE** applying with the University of Maryland online system. The ASRC Federal Terp Young Scholars Program Scholarship covers the cost of program tuition and lodging, transportation costs, and lodging during travel. Scholarships **DO NOT** cover baggage fees, books and course supplies, or spending money.

### Application Procedure

### **University of Maryland Terp Young Scholars Program Requirements**

1. Students must have completed 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, or 12<sup>th</sup> grade – but under the age of 18 at the time of travel
2. Students must have a current, cumulative 3.5 GPA/3.0 GPA. *Univ. of MD requires a 3.5 GPA, but may accept ASRC Shareholder students with a 3.0 GPA if not all placements have been filled by deadline. All references to GPA herein refer to cumulative GPA.*
3. Current Transcript
4. Recommendation letter

## **Official Scholarship Rules | ASRC Federal Terp Young Scholars Program Scholarship | Summer 2018**

1. **Eligibility:** Shareholders of the Arctic Slope Regional Corporation (“ASRC”) that have completed 9<sup>th</sup>, 10<sup>th</sup>, 11<sup>th</sup>, or 12<sup>th</sup> grade as of June 15, 2018, who are under the age of 18 at the time of travel, and have a cumulative GPA of at least 3.0, are eligible to enter the ASRC Federal Young Scholars Sponsorship Contest (the “Contest”).

2. **Contest Period:** The Contest begins at 9:00 a.m. Eastern Standard Time on February 1, 2018 and ends at 11:59 p.m. Alaska Standard Time on April 9, 2018 or until all 8 scholarships have been awarded, whichever occurs first (the “Contest Period”). Entries must be received by 11:59 p.m. Alaska Standard Time on April 9, 2018 to be eligible. Limit one entry per person and per e-mail address.

### **3. How to Enter:**

2. Once ASRC Federal has received the student’s application, verified eligibility, and responded with an online UMD application code, **Student will then be able to complete the Terp Young Scholars Program application via the University of Maryland website:**

4. **Selection of Winner and Awarding of Prize:** The University of Maryland Terp Young Scholars Program will select eight awardees from among all eligible entries with at least a 3.5 GPA on a first come, first serve basis based on the time of submission to the Terp Young Scholars Program application via the University of Maryland website (the “Selection”). Those applicants that have a 3.0 GPA will be waitlisted. If there are not eight eligible entries with at least a 3.5 GPA, the University of Maryland Terp Young Scholars Program will select students to fill the remaining slots from the waitlisted 3.0 GPA students on a first come, first serve basis. Awardees will be notified by phone and/or e-mail, at Sponsor’s discretion, on or about May 15, 2018. Return of any award notification as undeliverable may result in disqualification, and an alternate may be selected. The decisions of University of Maryland and the Sponsor are final and binding in all respects. The winners will be announced on or about May 15, 2018.

5. **Prizes:** The Prize for each winner consists of round trip airfare and program costs to attend the 2018 Terp Young Scholars Program at the University of Maryland in College Park, MD from July 8-27, 2018. The Prize **does not include** baggage fees, books and course supplies, and spending money during the program and while traveling. All expenses and costs associated with the acceptance or use of the prize that are not expressly specified in the foregoing prize description are the responsibility of the winner. There will be no substitution, cash redemption or transfer of the right to receive the prize permitted, except at the discretion of Sponsor, which reserves the right to substitute a prize of equal or greater value.
