## 2018 Scholarship Drawing Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED BY LAW.

### 1. Eligibility:

- To enter, you must be:
  - A shareholder of the Arctic Slope Regional Corporation (“ASRC”)
  - Between 14 and 18 years of age as of March 31, 2018
  - Registered as a student in the eighth through twelfth grades
  - In compliance with your school district’s attendance requirements and disciplinary policy
  - Have a current GPA of 2.5 or higher.
- To enter, your parent, legal guardian, or legal representative must also acknowledge that he/she has read and agreed to these contest rules on both your and his/her behalf.

2. How to Enter: The sponsor of this Drawing is ASRC Federal Holding Company, LLC (“ASRC Federal” or “Sponsor”). To enter, the entrant’s parent, legal guardian, or legal representative will be required to complete and submit an Official Entry Packet on behalf of the eligible entrant, and submit the packet to Sponsor either:

3. Date of Drawing: The Drawing will take place on or around Friday, March 30, 2018.

4. Grand Prize: The Grand Prize (“prize”), of which 14 in total will be awarded, consists of round-trip airfare, tuition, and room and board for the winners to attend the U.S. Space & Rocket Center’s Space Camp, which is located at One Tranquility Base in Huntsville, Alabama. All expenses and costs associated with the acceptance or use of the prize that are not expressly specified in the foregoing prize description are the responsibility of the individual winners. Under no circumstances will the Sponsor be responsible for providing a chaperone in connection with travel to claim a prize. Winners who, due to age, are required by law to participate in an airline’s Unaccompanied Minor Program must do so at their own expense. No substitution, cash redemption, or transfer of right to receive a prize will be permitted, except at the discretion of Sponsor, which reserves the right to substitute a prize of equal or greater value. The approximate retail value of each individual Prize is \$4000.00. The approximate total value of all of the Prizes is \$56,000.00. Only the prize specified above will be awarded. There is a limit of one (1) prize per person. Sponsor makes no representations or warranties concerning the safety or performance of any prizes awarded.

5. Selection of Winners and Awarding of Prizes: Eligible entries will be accepted between February 2 and March 26, 2018. Grand Prize winners are selected at random from among all eligible entries submitted at a drawing to be conducted by personnel from the U.S. Space & Rocket Center the “Drawing”). The Drawing will select 14 eligible students between the ages of 14 and 18 years old to attend either the Advanced Space Academy or the Space Academy depending upon age requirements of the programs. At Sponsor’s sole discretion, winners will be notified by phone and/or e-mail once his/her eligibility has been verified.

\* A winner’s parent, legal guardian, or legal representative will be required to complete and return a U.S. Space Camp Health Form prior to travel being booked. Travel must be booked at least 45 days prior to camp start. Failure to return the U.S. Space Camp Health Form or any other forms required by either the Advanced Space Academy or the Space Academy by the required deadline will result in forfeiture of the award. Return of any notification as undeliverable or Sponsor’s otherwise inability to contact winner or winner’s parent/ legal guardian/ legal representatives may result in disqualification. If for any reason a winner selected cannot accept a prize, an alternate may be selected at Sponsor’s sole discretion. Sponsor’s decisions are final and binding in all respects. The winners will be announced by no later than Tuesday, April 10, 2018.

6.
